I am strongly opposed to the draft Bill to facilitate access to public land within kunanyi/Mt Wellington Park for the purposes of a cable car project for the reasons listed below:

I believe that providing less than three weeks for public comments does not suggest a genuine desire from the government for public consultation.

This draft legislation undermines the current planning system designed to assess projects once a development application has been submitted and is clearly a step by the 'develop in natural areas at all cost government' to remove some of the checks and balances in place for projects of this nature. There are clearly government/private enterprise conflicts of interest and questionable motivation for such a drastic piece of legislation clearly designed to benefit a select few from a private enterprise.

Contrary to some claims and coverage, there is no 'social licence' for either the state government to acquire land through this draft legislation nor for the proponent to build a cable car of any description on kunanyi/Mt Wellington. You need to listen to the people who will be affected by this legislation and the proposed cable car project. Respect the Mountain!

A cable car up kunanyi/Mt Wellington would permanently damage this ancient dolerite landscape and Aboriginal heritage site. The aesthetics of beautiful kunanyi/Mt Wellington on and around the Organ Pipes would be permanently damaged, adversely affecting the experiences of hundreds of thousands of recreationalists, including walkers, climbers, mountain-bikers and motorists.

The Bill exempts the cable car project from the landowner consent requirements for public land and allows the State Government to acquire public land for private development. If passed, this Bill would set a dangerous precedent – giving the green light for further land grabs of public land for the sole benefit of private developers, not just for kunanyi/Mt Wellington but across the whole state of Tasmania.

Currently, permission from landowners would be required before the cable car proponent could enter land to undertake any work required to prepare a development application (e.g. surveying work, biodiversity studies, Aboriginal heritage assessments, traffic surveys). Under the Bill, the Minister can grant an authority to enter land, subject to any terms or conditions. As drafted, this power is not limited to land within Wellington Park owned by Hobart City Council and could potentially be used to authorise entry onto private land to carry out preliminary assessments. As mentioned above, this sets a dangerous precedent across all of Tasmania.

Land acquired under the Bill will become Crown land and remain as part of Wellington Park. However, Section 7G of the Land Acquisition Act 1993 requires parliamentary approval for acquired land to be used for any purpose other than the proposed infrastructure. So, unless specifically provided for in the acquisition order, this could prevent land acquired for the cable car from being used for public recreation. I am concerned that residents of Hobart and visitors could potentially be locked out of the 'acquired' crown land on the eastern face of kunanyi/Mount Wellington which was originally set aside for the protection of its natural and cultural values and has been utilised for recreation and socialisation since European settlement in Hobart.

Please consider all of these points when assessing the merits of this drastic proposed legislation and its impacts on the mountain and its implications for the future generations of Tasmanians, our children and our children's children's ability enjoy the the natural wonders of this state. This proposed legislation and the cable car proposal are not in the best interest of the people of Tasmania. The draft legislation should not pass if you are serious about your role of representing the people of Tasmania and their best interests.

I wish to express my deep opposition to the proposed legislation to facilitate the construction of a cable car system on kunanyi/Mount Wellington. It is disturbing that no lessons seem to have been learned by this government following on from the debacle of the previous 10 years and Gunns' attempt to build a pulp mill. When a project comes forward where the developer can't or won't abide by existing planning and application processes, it is not appropriate for them to use personal relationships with ministers to circumvent those processes.

Beyond the appearance of ill advised interference in a normal development application, the proposed legislation offers no comfort to a passionate local community as to how the land use is to be regulated or how any dividend to the community shall be measured and levied. Neither is any mention made of requirements upon a developer to remedy the site should the project fail.

It is not good enough that a public asset such as kunanyi/Mount Wellington be offered to any private developer without an accompanying requirement for the funds necessary to fully remediate all construction sites to be deposited with the Wellington Park Management Trust. It would be the height of naivety to accept the word of any company that they would hold sufficient funds in reserve to remediate public land should a venture fail. kunanyi/Mount Wellington is iconic to Tasmanians, it holds inexplicable value both to our first peoples and to many locals whose lineage under its shelter start more recently.

This value is not to be exploited by the gamble of prospectors looking for the next tourist thrill, especially when tourists are increasingly shirking gimmicks in search of authentic experiences. You do not enhance a wild place by installing cafés and gift shops upon it. Suggestions on the current proponent's website for the service of alcohol at the summit display a complete disregard for the unforgiving nature of the environment immediately outside the visitors centre and these proposed facilities highlight the inherent flaw of the proposal - no proposed cable car service values the experience of the mountain alone as reason enough to attract the necessary visitors to sustain it financially and so insist that further development of the summit is necessary.

Please do not hand our mountain over to a private developer to stake their fortune upon, it will be forever altered by any such undertaking no matter how well intentioned the proponents may be. From gondolas traversing the organ pipes to private functions at the summit, the simple yet priceless experiences of being on the mountain stand to be diminished and we that are of the mountain will lose something of ourselves too.

SUBMISSION DRAFT MOUNT WELLINGTON CABLE CAR FACILITATION BILL 2017

I write in response to the Department of State Growth's invitation for written feedback relating to the Draft Mount Wellington Cable Car Facilitation Bill 2017.

By way of background, I am a retired qualified civil engineer with 37 years of experience in Tasmanian civil and municipal engineering, with over 30 years employed at the Hobart City Council. I retired from the position of Director Infrastructure Services at the end of 2011. My experience at the Hobart City Council included the development, design and construction of many multi-million dollar infrastructure projects including the revitalisation of the Central Business District, the Sandy Bay Sewerage Scheme, the Hobart Aquatic Centre, the Sandy Bay Beach Redevelopment, the redevelopment of the North Hobart Shopping strip as well as a wide range of projects in water supply, sewerage, sewage treatment, stormwater, roads, traffic and waste engineering.

I object to the draft legislation in the strongest possible manner based on the following grounds:-

1. The draft legislation is unnecessary.

The cable car proponent is at liberty to formally seek the permission of the Hobart City Council, as owner of the "project land", to lodge a Development Application for the cable car proposal.

The cable car proponent is also at liberty to formally seek the permission of the Hobart City Council to enter the "project land" in order to undertake investigations, testing, assessments and the like to assist in the preparation of a Development Application and supporting documentation for the cable car proposal.

To the best of my knowledge, no such permissions have been sought from the Hobart City Council by the cable car proponent.

At the very least, any further progressing of the Draft Legislation should be put on hold until the cable car proponent:-

(a) formally seeks the permission of the Hobart City Council to lodge a Development Application for the cable car project and to enter the "project land" in order to undertake various investigations, testing and assessments; and

(b) the Hobart City Council responds.

2. The draft legislation is an abuse of power.

As stated above, there are existing and fully functional mechanisms in place to allow the cable car proposal to be properly considered by the relevant land owners, planning authorities and members of the public. The community views on this proposal are strong and diverse and until such time that a development application is lodged and processed in the normal way, community attitudes to the proposal have yet to be properly gauged. For the Government to pre-emptively draft this legislation is an abuse of the power that has been entrusted to it through its election by the community.

The Government does not have a mandate from the community to enact this legislation.

3. The draft legislation is heavy handed.

The draft legislation facilitates the compulsory acquisition by the Government from "....a council...." (i.e. the Hobart City Council) of "....land, within Wellington Park...." that would be required for the development of the cable car proposal.

The draft legislation also facilitates the compulsory acquisition by the Government of airspaces from unspecified land owners that would be required for the development of the cable car proposal.

The proponent does not own any of the land that his proposal is planned to occupy or pass over. This is an unusual situation for a developer to be in.

Rather than rely on heavy handed, project specific, new legislation, the proponent should be required to negotiate sensitively and fairly with affected land owners in order to gain ownership or easement rights over their land.

If these negotiations are ultimately unsuccessful, then the proposal cannot, and should not, proceed.

4. The draft legislation is vague and open-ended.

The draft legislation fails to specify the location, size or shape of the land which it sets out to acquire. There is no limit to the extent of the land to be acquired.

Likewise, the location, size and shape of the airspaces to be acquired are not specified. Again, there is no limit to the extent of the airspace to be acquired.

While the proponent of the cable car proposal has prepared hard-sell promotional material with some indicative sketch drawings, none of this has been translated to enable the land and airspace acquisition requirements to be actually and properly prescribed in the draft legislation.

5. The draft legislation is undemocratic.

It is unacceptable that a properly elected government should draft legislation that facilitates its own compulsory acquisition of land and airspace to enable a private development to proceed on and above unique public land for what is essentially a money making scheme for the sole benefit of a profit motivated developer.

6. The draft legislation is inappropriate.

The development of a cable car across the face of kunanyi / Mount Wellington is entirely inappropriate. I would find such a development to be grossly offensive and intrusive in this magnificent natural landscape.

Tasmania is now at a crossroads. As a state, we must be extremely careful not to ruin the very thing that makes it such a universally popular destination for people from the mainland and overseas. It is the unspoilt, natural and rugged beauty that makes our island state unique.

Moreover, the cable car proposal would have an adverse localised impact on many properties along the proposed route and, in particular, to residential amenity in South Hobart. Traffic management issues would arise at the commencement point of the cable car, shown to be adjacent to the Cascade Brewery, with parking and pedestrian safety issues of particular concern. There is already a safety deficient pedestrian crossing facility at the Strickland Avenue corner at the site of the Cascade Brewery

7. The draft legislation is unsuitable.

Section 5(1) of the draft legislation provides that "Part 1A of the Land Acquisition Act 1993, and any other provision of that Act that is relevant to the operation of that Part, applies in relation to project land as if the project were a service prescribed for the purposes of paragraph (i) of the definition of infrastructure in section 7A of the Land Acquisition Act 1993."

Section 7A of the Land Acquisition Act 1993 provides that "....infrastructure means any structure, facility or work arising in connection with the provision to the public or a section of the public of services relating to water, energy, communications, transport, education, health, emergency response, sewerage and any other service which may be prescribed."

The nature of this cable car proposal in my opinion precludes it being considered as "infrastructure" as defined by the Lands Acquisition Act 1993 in that it does not provide a service to the public. It is therefore contrary to the intent of the over-arching Lands Acquisition Act 1993.

I trust that you will ensure my views are taken into account when the progress of this proposed legislation is further considered by the Government.

I wish to express my opposition to the current plan to acquire land for the cable car project. My husband, Andrew Tompson, comes from a background of many years of dealing with Council issues in an extremely responsible role within the Hobart City Council and has already outlined many legal reasons why this draft legislation is inappropriate. I agree totally with all his reasons and do not wish to repeat them so refer you to his submission of the 3rd August 2017. However I do wish to state to that I am disgusted at the contempt and disregard shown for the normal, very necessary and fair processes that are already in place for such proposals.

I also wish to add some of my own feelings on this proposal as a resident of Hobart since my birth in 1952. I have a great love of kunanyi/Mount Wellington, having grown up in Lindisfarne with a stunning view of the mountain in all its moods from the glorious dawn to the beautiful evening light, to storms and snow.... the list goes on.

It has also been a favourite place to visit at all times of the year and I share the frustration of not being able to use the road in snowy conditions. However, I do not believe we are entitled to destroy the beautiful face of the mountain just to satisfy our desires and cannot believe that serious consideration is being given to a proposal will take the cable car right across the face of the Organ Pipes – one of the most amazing and loved features of our mountain.

The residents within the area most affected by this proposal clearly also have a deep love of the mountain and have chosen to live within its shadow to experience its power and majesty everyday of their lives. They are a group of people concerned to live with a light footprint on the planet and live in harmony with nature and while new legislation means this is of no account, this is an extremely worrying and horrifying trend currently being set by this government. The will of the people is of little interest to them if it stands in the way of development and this case is particularly upsetting and unacceptable as this land 'grab' (because that is what this is) benefits solely a friend of the minister who should have long ago declared an interest and walked away. Meanwhile the peace and serenity of the lives of the residents will be destroyed by towering monuments to developmental stupidity and constant grinding noise which will be heard throughout the district.

The proposal by the developer thus far is totally inadequate and vague, again showing contempt for the public and gullibility of the government in going to such (unnecessary) lengths to support such a poorly defined project. Another glaring omission is any information on the costs to the users once it is running. I suspect that most local people who do support the proposal, believe they will be able to take their families to the top whenever they like. Judging from prices of such instalments in Europe, it is likely that it will be priced beyond the reach of many families to enjoy once, let alone 'whenever they like'. I would call upon the developer to publish his proposed pricing (to which he should be bound) and then recheck public support. If it is out of the price range of average families and becomes largely a tourist attraction, then we risk ruining the very thing that attracts tourists to our state and when the tourists have had their fill, what plan is in place for the developer to clean up the derelict remains?

Tasmania is one of the few places left with much of our natural beauty intact, but this government is demonstrating at an alarming rate that it is willing to destroy the very things that attract people to visit and even to move here permanently. That business is given such a free hand and such favouritism currently is deeply disturbing – I have a growing feeling that we are no longer living in a democracy, but rather an ever-growing dictatorship, with little to no regard for public opinion.

A fine example of this is the granting of permission for the salmon farming in Okehampton Bay, where not only has this environmentally damaging project gone ahead with alarming speed, but we now find on the eve of the approval that there is also a 'commercial in confidence' desalination plant involved. The potential for damage to the environment in this beautiful bay is immense and once again public opinion has been completely ignored.

I cannot adequately describe the sense of anger, disgust, frustration and hopelessness I feel when hearing the growing list of mindless commercial decisions being made for the benefit of profit motivated individuals with short term goals in mind and little regard for the long-term effect they will have on our beautiful island.

The most dangerous thing about this legislation is the fact that this removes public debate about the cable car, as well as the dangerous precedent it creates for future developments.

It shifts any debate away from 'is this a good idea' to 'can this fit within the development criteria'.

Ever since this debate has begun, myself and others have been calling for detail but the proponent has been holding details to ransom until he is given the irreversible landowner consent. Irreversible because once provided, it cannot be removed at a later date. Sure it can be knocked back if he decides to build a 120 story building on the summit because that's against the plan. But so long as building heights are correct, floor sizes are acceptable, then there is no opportunity for debate. That time has passed.

Debates about these details are incredibly important on both sides. It promotes intelligent discussion and helps to avoid white elephants and eyesores. Since the proponent has last spoken to Hobart City Council, the images of what the proponent are promoting have changed in major ways at least twice. These modifications have naturally happened because someone saw an issue with the previous design. These issues may have been cosmetic, or they may have been critical to protect something natural. But they only occurred because some people debated ideas. If further evidence is required about the lack of intelligent conversation present it can be no more obvious than to watch the obscene swearing and abuse displayed by supporters of a cable car to people simply asking questions. Reading threads on some online discussions can be akin to reading a transcript from the crowd at a Trump Rally.

If this legislation is passed, then intelligent conversation disappears with it. The question no long becomes 'is this something that Hobart wants/needs', rather 'how can we get this project to fit within the requirements?'.

By withholding critical information from the pubic shows a lack of transparency and trust. Previous scandals about people against the cable car have centred around information being leaked out.

The cited reason that they don't want to deal with Hobart City Council isn't that they cannot go any further, but rather that the proponent doesn't want to negotiate with them because of a claimed leak that has been denied. Official complaint channels haven't been instigated by the proponent to back up his claim. Hobart City Council, at their recent meeting, started clearly, in the presence of the proponent, that a DA could in fact be submitted to Council the next day if he wanted to.

The apparent 'leaked' commercial in confidence information was nothing to do with the business or marketing plan or commercial strategy – it was the height of the towers. The same drawing supplied to the public the day before, but they didn't want the public to know how high they would be. This is not information critical to the business surviving. This is information that would affect the public but the proponent didn't want to share it. If this is such a winning idea, why can't even basic information by provided to the public? If there is nothing to hide about the design or how it will really look, why not release the information for independent analysis? This is a development that will take place on one of the most iconic locations in Hobart. Author Peter Conrad once wrote "Hobart belongs to [kunanyi] Mount

Wellington" The relationship that many locals have to the mountain is deep and defining of their person. To propose drastic modification to it behind closed doors feels like a personal attack to many.

This lack of trust between the proponent and the public has lead to skepicism and lack of community support. Recent polls published in a local newspaper suggested wide community support. However when placed against previous polls commissioned by the proponent or ReachTel, it shows support is declining. Within the Denison electorate, less than 50% of people surveyed support it.

But this legislation is not about whether or not a cable car should go on the mountain. This asks the question about can a developer get preferential Government treatment for a private enterprise on public land without needing to show any detail.

There is no reason for this legislation to go ahead. The pathway is there with Council so long as the proponent is willing to be more transparent. This Bill seeks to shepherd a coward from public scrutiny. To paraphrase the iconic movie The Castle, this compulsory land acquisition will not be on just terms.

I urge anyone that has authority, not to allow this legislation to go to Parliament. It will set a precedent for the removal of intelligent debate that would normally help strengthen the future of Tasmania.

Submission on draft legislation to facilitate access to public land within kunanyi/Mt Wellington Park for the purposes of a cable car project.

I submit that this draft legislation must be abandonded and not put before the parliament of Tasmania.

It is inappropriate for the Department of State Growth to attempt to interfere with planning and management processes that are in place for Wellington Park.

The public land on Mt Wellington that is the subject of this draft legislation is owned by the Hobart City Council (HCC) and managed under the auspices of the Wellington Park Management Trust (The Trust) which has in place a management plan.

To the best of my knowledge, no proponent has yet sought consent from the relevant landholder, HCC, to lodge a development application(DA) for a cable car project on the mountain. There is no evidence to suggest that the HCC would refuse such consent. Consent to a DA being lodged doesn't imply approval of the DA.

The HCC and The Trust must be permitted to manage Wellington Park and consider DAs for cable car projects, and any other projects, without interference by the Department of State Growth.

Providing less than three weeks for public comments does not suggest a genuine desire for public consultation. A cable car up Mt Wellington would permanently damage an ancient landscape and Aboriginal heritage site. The aesthetics of beautiful Mt Wellington on and around the Organ Pipes would be permanently damaged, adversely affecting the experiences of hundreds of thousands of recreationalists, including walkers, climbers, mountain-bikers and motorists. The metal, glass and concrete of a cable car, its terminus and its pylons will intrude upon the magnificent views of Mt Wellington that are enjoyed by tens of thousands of people from many different aspects. The Bill exempts the cable car project from the landowner consent requirements for public land and allows the State Government to acquire public land for private development. If passed, this Bill would set a dangerous precedent – giving the green light for further land grabs of public land for the sole benefit of private developers. Currently, permission from landowners would be required before the cable car proponent could enter land to undertake any work required to prepare a development application (e.g. surveying work, biodiversity studies, Aboriginal heritage assessments, traffic surveys). Under the Bill, the Minister can grant an authority to enter land, subject to any terms or conditions. As drafted, this power is not limited to land within Wellington Park owned by Hobart City Council and could potentially be used to authorise entry onto private land to carry out preliminary assessments. Land acquired under the Bill will become Crown land and remain as part of Wellington Park. However, Section 7G of the Land Acquisition Act 1993 requires parliamentary approval for acquired land to be used for any purpose other than the proposed infrastructure. So, unless specifically provided for in the acquisition order, this could prevent land acquired for the cable car from being used for public recreation.

I wish to make a submission to the Mt Wellington Cable Car Facilitation Bill 2017.

I believe the process behind this Bill to be fundamentally flawed- privileging as it does a single development proposal, the details of which are not clear to either the major landowners affected nor the people of Tasmania.

That the would be developer is a known friend of the Minister responsible for this Bill reeks of endemic cronyism. That only 3 weeks have been given for public comment, with no supporting public meetings to allow questioning of officials about the intent, extent or ramifications of this Bill, compounds the sense of mistrust. It is a Bill aimed at facilitating an individual developer to avoid having to undertake a full, open and democratic process around a contentious proposal.

The aesthetics of Mt Wellington, including around the iconic Organ Pipes would be permanently damaged by a cable car. The infrastructure of a cable car will intrude upon the magnificent views of Mt Wellington that are enjoyed by tens of thousands of people from many different aspects.

The Bill exempts the proposed cable car project from the landowner consent requirements for public land and allows the State Government to acquire public land for private development. If passed, this Bill would set a dangerous precedent – giving the green light for further land grabs of public land for the sole benefit of private developers.

I urge you to reject this Bill, as I believe that it skews the democratic process and will mean that a development which has the potential to intrude upon the amenity of many is subject to a lesser standard of scrutiny than it requires.
