STRATEGIC REVIEW OF KUNANYI/MOUNT WELLINGTON

I write further to the Council meeting of Monday 22 July 2024, during which the Council considered a Notice of Motion from Councillor Lohberger and the Deputy Lord Mayor in relation to Halls Saddle being incorporated into the strategic review of kunanyi/Mount Wellington. A copy of the Minute is attached for your reference, with the Council resolving that:

"...the Halls Saddle site (220 Waterworks Road, Ridgeway) should be included in the proposed State Government Strategic Review of kunanyi/Mt Wellington, despite the fact that the site is outside the current Wellington Park boundary."

As you are aware, the City of Hobart is the long-term management agency for the most highly visited areas of the mountain and own and manage the majority of assets that support visitor access and use, including the Halls Saddle site for which the City invests in its ongoing maintenance. Whilst the site sits outside the Wellington Park boundary, it has the potential to play an important role in the future management and operation of kunanyi/Mount Wellington and therefore, it is important for consideration to be given for its inclusion in the strategic review process.

The Council also resolved that an open day at Halls Saddle be held in conjunction with the Department of State Growth to highlight to the community the site and its wide-ranging benefits, including its potential as a transport and or visitor hub.




