
Communiqué #3 – King Island Response Team



Message from the Premier and Minister for Trade and Major Investment, and Chair of the King Island Response Team, Jeremy Rockliff.

Recently we met for the third time as the King Island Response Team.

We welcomed Sally Haneveer, the manager of Phoenix Community House, who has joined the group to add the community perspective.

I understand that the entire island is waiting for news of a sale for the dairy, and we are doing everything we can to assist with that.

From a government perspective, the Office of the Coordinator General continues to work with the company and has completed site visits with consultants to be able to assist potential purchasers of the dairy.

It is good to hear that Saputo continues to engage with its employees at the dairy and on the farms, keeping them as informed as possible about the future of the operations.

Recently I wrote to the managing directors of both Woolworths and Coles to urge them to continue to stock and promote King Island Dairy products to ensure the markets are maintained for the future.

State Growth's Small Business unit also expanded the capacity to provide support to King Island under the Tasmanian Business Advice Service and New Business Support Pilot Program.

This will mean the opportunity for more meaningful face-to-face and virtual support for businesses on the island regardless of what happens with the dairy, particularly those who were part of workshops with the Braddon Business Centre during September.

State Growth are continuing to work with the council and other members of this group to look at a variety of other options to support and grow the island economy.

The Council has worked with other organisations to put together some opportunities to ensure the future sustainability of the island economy and community. The government will consider these and see where we may be able to support these initiatives.

It was pleasing to hear that more than 30 people gathered in October for the freight and logistics roundtable, and we better understand the freight challenges facing the island, particularly for the primary producers who are the heart of the island economy. Work continues to find ways to increase the freight options and reduce costs for all.

During this meeting we discussed the ongoing efforts of the Council and others to explore shipping options from King Island. We also heard from Mayor Blackie and Senator Urquhart about the inquiry into the Tasmanian Freight Equalisation Scheme which was held on the island recently. Everyone is now awaiting the release of the committee report later in December and we hope it will include recommendations that will be positive for King Island.

I note that there is a drought planning forum coming in December to help both the farming sector and broader community prepare for what could be another dry summer. I would encourage everyone who can to be part of the sessions on December 12.

This follows on from several more specialised workshops over the winter and spring, and support mechanisms like this will continue and be scaled up depending on the season.

The Response Team is scheduled to meet again this month, and I look forward to hearing more about the progress of these and other initiatives to strengthen the island economy into the future.

And I'm hoping to be on the island early in the New Year, and I'm certainly expecting there will be a lot more certainty by then.

Primary Producers Emergency Response Grant Program

Emergency Recovery Grant - Non-profit Organisations
